2 College/ Career Indicator Report: 2017.

2017 was a pilot year for the California school dashboard to include measures of college and career readiness (CCI). The CCI for the 2017 Dashboard is based on students in the four-year graduation cohort for comprehensive high schools. It used data on graduates in the class of 2016 to determine the number and percentage of students identified as "prepared," "approaching prepared," or "not prepared." Due to the California Longitudinal Pupil Achievement Data System (CALPADS) reporting timelines, the Class of 2017 graduation data were not available for the 2017 CCI.

The 2017 CCI report displays the number and percentage of graduates in the class of 2016 that met the criteria for each of the measures in the CCI Prepared and Approaching Prepared Levels. Students can meet more than one measure in each CCI level. As a result, the tables contain duplicative counts. In 2017, there were 5 different measures of College and Career Readiness.

These were:

Measure A: Career Technical Education (CTE) Pathway Completion with a C minus or better in the Capstone Course plus one of the following measures:

- Smarter Balanced Summative Assessments: At least a Level 3 "Standard Met" on ELA or Mathematics and at least a Level 2 "Standard Nearly Met" in the other subject area
- One semester/two quarters of Dual Enrollment with grade of C- or better (Academic/CTE subjects).

Measure B: At least a Level 3 "Standard Met" on both ELA and Mathematics on Smarter Balanced Summative Assessments.

Measure C: Completion of two semesters/three quarters of Dual Enrollment with a grade of C minus or better (Academic and/or CTE subjects).

Measure D: A score of 3 on two Advanced Placement (AP) Exams or a score of 4 on two International Baccalaureate (IB) Exams.

Measure E: Completion of courses that meet the University of California (UC) or California State University (CSU) a–g criteria with a grade of C- or better, plus one of the following criteria:

- CTE Pathway completion with a C- or better on the capstone course

The Dashboard was updated in 2018 as follows:

- Use of Most Current Data: Compared to the "lagging data" used to report the College/Career Indicator (CCI) for the Fall 2017 Dashboard, the 2018 Dashboard uses the most current data.
- Inclusion of students who took the California Alternate Assessment (CAA): In the past, students who took the CAAs were not included in the College/Career Indicator (CCI) and were removed from the calculations. Beginning with the 2018 Dashboard, all students in the four-year graduation cohort, including those who take the CAAs, are included in the CCI calculations.
- Approval of new measures: At the September 2018 State Board of Education (SBE) meeting, the SBE approved the inclusion of the State Seal of Biliteracy and the Leadership/Military Science as additional measures in the CCI.
- New Change cut scores: In 2017, only the Status cut scores were approved for this indicator. The Change cut scores were approved by the SBE at their November 2018 meeting. For schools and LEAs to demonstrate success on this state indicator, high school graduates must meet at least one of the measures in the prepared level.

The 2018 CCI report displays the number and percentage of graduates in the class of 2018 that met the criteria for each of the measures in the CCI Prepared and Approaching Prepared Levels. Students can meet more than one measure in each CCI level. As a result, the tables contain duplicative counts. Only measures currently collected statewide at an individual student level are included in the CCI. In 2018, there were 8 different measures of College and Career Readiness.

They are:

- CTE Pathway Completion
- Grade 11 Smarter Balanced Summative Assessments in ELA and Mathematics
- Advanced Placement (AP) Exams
- International Baccalaureate (IB) Exams
- College Credit Course (formerly called Dual Enrollment)
- a-g Completion
- State Seal of Biliteracy (New for 2018 Dashboard)
- Leadership/Military Science (New for 2018 Dashboard)

The "a-g completion" requirement for the 2018 Dashboard was extracted out of theCalifornia Longitudinal Pupil Achievement Data System (CALPADS) Operational Data Store (ODS) on September 14, 2018. This is the "Student Met All UC CSU Requirements Indicator" in CALPADS (field #1.29). When the student graduates, the LEA marks the student record (with a Yes or No) as to whether the student completed a-g requirements.

Pass UC/CSU a-g required courses with C minus or better and complete one of the following: pass Smarter Balanced Summative Assessments with a level 3 or higher in ELA and at least a Level 2 in mathematics, or Level 3 or higher in mathematics and at least a Level 2 in ELA; complete one semester/two quarters/two-trimesters of College Credit Courses with a grade of C- or better in academic/CTE subjects where college credits are awarded for each course; score of 3 on one AP exam or score of 4 on one IB exam; or completion of CTE Pathway.

2 Report Description: "This report displays the college-going rate (CGR) for all California public high school students who completed high school during the selected reporting year by Race/Ethnicity, Student Group, or across multiple academic years (Multi-Year report) for the selected reporting level (state, county, district, or school). This report provides both a count and a rate of high school completers who enrolled in a postsecondary institution of higher education (e.g., college or university) within 12 or 16 months of completing high school, based on available report filters.

The student-level high school completion data used to calculate the CGR were submitted by local educational agencies (LEAs) and charter schools to the California Department of Education (CDE) as part of regular student enrollment, demographic, and program subgroup updates submitted to the California Longitudinal Pupil Achievement Data System (CALPADS) Operational Data Store (ODS) and as part of the annual CAL-PADS End-of-Year 3 (EOY 3) submission.
